Voluntary Check-Off Authorization to Any Employer Under Contract with United Food & Commercial Workers Union, Local 1994 MCGEO

You are hereby authorized to deduct from my wages, commencing with the next payroll period, an amount equal to all Union dues and other fees as approved by the membership of Local 1994 MCGEO of the United Food and Commercial Workers International Union, and to remit the same amounts to the Secretary-Treasurer of UFCW Local 1994 MCGEO. This authorization is voluntarily made in consideration of the cost of representation and other activities undertaken by UFCW Local 1994 MCGEO and is irrespective of my membership in the Union.

This authorization and assignment is without condition and shall be irrevocable for a period of one year from the date of execution or until the termination date of the agreement between the Employer and Local 1994 MCGEO, whichever occurs sooner, and from year to year thereafter, regardless of union membership, unless not less than thirty (30) days and not more than forty-five (45) days prior to the end of any subsequent yearly period or the termination of the collective bargaining agreement between the Union and my Employer, I give the Employer and the Union written notice of revocation bearing my signature thereto.

The Secretary-Treasurer of Local 1994 MCGEO is authorized to deliver this authorization to any Employer under contract with Local 1994 MCGEO, and is further authorized to transfer this authorization to any other Employer under contract with Local 1994 MCGEO in the event I should change employment or to the same Employer if I return to work after hiatus.

Dues/ fees, contributions, or gifts to MCGEO are not tax-deductible as charitable contributions for federal income tax purposes. However, they may be tax-deductible under other provisions of the Internal Revenue Code. I also understand that it is my responsibility to notify MCGEO if my employment status changes and I am no longer covered by a MCGEO collective bargaining agreement.
